Lot 2 extends to 20.26 acres (8.20 ha) or

thereabouts. The Lot is accessed from the main road located within Kirkandrews-on-Eden as shown on the attached sale plan. The residential properties known as Sunnyside and Ewhurst have a right of way over the access track. The three field enclosures are sown down to permanent pasture. Included within the Lot is a former dismantled railway line which in total extends to approximately 5 acres and is now reverting to nature with areas of trees and scrub located within it providing potential for this area to be enhanced to form a substantial wildlife corridor.
