### Introduction / Location

The land lies in open countryside lying to the east of the B5300 Silloth to Maryport road northeast of the hamlet of Beckfoot as shown on the attached sale plan.

### Method of Sale

The property will be offered for sale by private treaty as a whole. Offers are to be made in writing to Ian Ritchie Land Agents Ltd.

### General Description

The land lies in a block of three adjoining field enclosures extending to 16.25 acres (6.58 hectares) or thereabouts. The property will be granted a right of way for all agricultural purposes over and along a new access way to be created by the vendor prior to completion between points A and B on the sale plan. Fields 1 and 3 are currently in Spring Barley which will be harvested prior to completion with the fields being left in stubble. Field 2 is currently in temporary grass. The property is to be sold without a mains water supply. However, if the purchaser wishes to make their own connection to the United Utilities watermain it will be possible to install a waterpipe along the route of the access track marked A B on the sale plan.

The land lies outside the Nitrate Vulnerable Zone.

## General Remarks

### Tenure
